Competitive Admission Process (2018-19 Academic Year)  
**POINT SCALES FOR ALL PROGRAMS**

WCC has a competitive admission process for all programs that have been designated as high demand (one for which there are more qualified applicants than openings for an entering class). Applicants are required to meet all prerequisite/admission criteria and will be ranked based on a point system with the best qualified applicants being selected for admission. WCC's competitive admission point scales for all programs are listed below.

Students are encouraged to meet with an advisor to discuss the timing and selection of admission requirement and support courses. Advisors are available to meet with students on a walk-in basis or by appointment during regular business hours. **All GPA calculations will be based on a 4.0 GPA scale. All course grades including transfer courses will be calculated based on WCC's Grading Scale below.**

**1. CUMULATIVE PROGRAM PREREQUISITE GPA**

The student's grade/GPA of all required program prerequisite courses will be included in the calculation. Students will be awarded points based on their cumulative program prerequisite GPA according to the scale below.

**How to calculate:**

*Number of Credit Hours of course X Grade Points Per Credit Hour = Quality Points (See WCC's Grading Scale on page 1 to determine grade points.)*  
*Sum of Quality Points from all prerequisite courses / Sum of GPA Credit Hours from all prerequisite courses = Cumulative Program Prerequisite GPA*

**2. CUMULATIVE COLLEGE GPA (or when meeting program specific prerequisites, the Cumulative High School GPA may be calculated)**

The student's total cumulative GPA of all schools that provide a required program prerequisite course will be included in the calculation. The total cumulative GPA between all schools will be rounded to the second decimal place. Students will be awarded points based on their cumulative college/high school GPA according to the scale below.

**How to calculate:**

*Sum of Quality Points from all schools / Sum of GPA Credit Hours from all schools = Cumulative College/High School GPA*

**3. ATI-TEAS SCORES** – Only used for Registered Nursing (APNURS) applicants.

Student's will be awarded points based on the average of all four (4) subjects (Reading, Mathematics, Science, and English Language Usage) using the highest subject score from each test taken.

**How to calculate:**

*Sum of all 4 subject scores / 4 = Average TEAS Score*

**4. NURSING PRE-ENTRANCE MATH TEST SCORES** – Only used for Nursing Transfer (APNURE) applicants.

Students are awarded points based on the student's test score and whether they successfully completed the test within one (1) or two (2) attempts.

**5. RESIDENCY STATUS**

Students are awarded points based on residency status. Residency status is based on where the student resides and is verified with a Driver's License, State ID, or other acceptable documentation that has been approved to verify residency status at WCC. **6. CUMULATIVE SUPPORT COURSE GPA BASED ON PERCENTAGE COMPLETED**

Students are awarded points based on the cumulative GPA of all support courses completed and the percentage of support courses completed by the application deadline. This includes all defined courses plus substitutions that are approved by the department prior to the application deadline. Points are awarded according to the scale below.

**How to calculate:**

*Number of Credit Hours of course X Grade Points Per Credit Hour = **Quality Points*** (See WCC's Grading Scale on page 1 to determine grade points.)

*Number of Support Courses completed / Total number of Support Courses possible X 100 = **Percentage of Support Courses Completed***

*Sum of Quality Points from all Support Courses completed / Sum of Credit Hours from all Support Courses Completed = **Cumulative Support Course GPA***

**7. EXPERIENCE**

Students will only be awarded points for one (1) of the items below (section A, B, or C). Points will not be awarded for experience that is required to meet prerequisite or program requirements. (i.e. Physical Therapist Assistant students will not be awarded points for completing observation hours.) All experience is evaluated by the departments after the application deadline. The *Experience Form* can be found in the program application packet on WCC's Enrollment Steps for Health and Second Tier Program Students page at <http://www.wccnet.edu/studentconnection/admissions/health-second-program/>.

**A. Employment Experience**

Students must have **direct patient care** work experience in a **hospital or health care facility/agency** within 8 years of the application deadline. Students must verify they work a minimum of 30 hour per week for full-time status and a minimum of 15 hours per week for part-time status. The student and their employer/supervisor must complete the *Experience Form* to verify experience. Veterans must submit form **DD-214** to verify experience.

**B. Community Service and Volunteer Experience**

Student's must have community service and/or volunteer experience with **direct patient care** that takes place in a **hospital or health care facility/agency** within 8 years of the application deadline. The student and their employer/supervisor must complete the *Experience Form* to verify experience. Student's submitting a certificate and/or letter to verify hours, must complete the above form and attach all documentation.

**C. High School Health Science Technology Programs**

Students who have successfully completed a high school health science technology program (minimum of 1 year) with a minimum grade of C/2.0 must complete and submit the *Experience Form* and attach an official high school transcript.

**8. VETERAN STATUS**

Students must verify status by submitting form **DD-214**.

**9. ASSOCIATE OR HIGHER DEGREE FROM AN ACCREDITED U.S. COLLEGE/UNIVERSITY**

Students must submit official transcripts with posted degree.

**10. COURSES TAKEN AT WCC**

Students can be awarded additional point(s) for each prerequisite and support course taken at WCC. Points will only be awarded for courses that are used to meet application requirements. If a single course is used to meet both a prerequisite and support course requirement, students will only be awarded 1 point (students will not be award an additional point for the same course).

**11. ALTERNATE CANDIDATE STATUS**

Students reapplying to the program who made alternate candidate status based on a previous application and who did not make admission to the program will be awarded additional points. Additional points will only be awarded to students who made alternate candidate status under WCC's competitive admission process and not the old waitlist process.

**12. TIE BREAKERS**

If there are applicants who have an equal number of points and are tied for the last available seat in the program, the following tie breakers will be used:

- A. Student with the highest Cumulative Program Prerequisite GPA.
- B. Student with the highest Cumulative College GPA (or when meeting specific program prerequisites, the Cumulative High School GPA may be used).
- C. In the unlikely event that applicants are still tied after evaluation of tie breakers A and B, applicants will be chosen based on a lottery for their position in the class.

**13. EXTENUATING APPLICATION PROCESS FOR PROGRAMS THAT HAVE SEATS AVAILABLE AFTER INITIAL APPLICATION DEADLINE**

In the event that there are more accepted and/or alternate candidate seats available than completed applications received at the end of the initial application deadline, the application will remain open until all seats in the program are filled. At this time, students who do not meet all admission requirements but who anticipate meeting all requirements by the date specified in the application packet are encouraged to submit their incomplete application to be considered for a seat on a conditional basis. As soon as all seats are filled, the application will be closed and applications will no longer be considered for the current admission cycle. In this case, students will be considered for an accepted or alternate candidate seat based on the following:

- A. The date the student's application was received by the Health and Second Tier Admissions Office.
- B. If multiple applications are submitted in a day, applicants will be chosen based on a lottery for their position.
