BACKGROUND

The immediate costs related to the emergency repair of the sanitary pipe, including the installation and winterization of the over-ground pipe, is being paid from the CRM Fund. The high cost of this emergency repair and temporary pipe, estimated at \$284,291 will deplete the CRM Fund.

To continue to fund Campus Repair & Maintenance through the remainder of the fiscal year, the college is proposing a transfer from the Capital Fund. The college has five projects in the Capital Fund that were completed under budget. This excess funding totals \$127,101. Additionally, there is miscellaneous revenue of \$17,967 in the Capital Fund related to escrow refunds received after projects were closed. In total, there are excess funds of \$145,067 in the Capital Fund.
