# WCC Mentoring for Success Program

## Two Mentoring Components

### Peer to Peer Mentoring:

Peer to Peer mentoring is a collaboration between the Student Resource and Women's Center, Nursing Faculty and Nursing Club. Peer mentors and incoming nursing students attend a workshop to obtain information and connect. This workshop occurs twice a year based on date of the nursing new student orientation. The students are able to contact their mentors throughout the beginning of their first and second semesters.



### Professional Mentoring:

Professional mentoring is a collaboration between the Student Resource and Women's Center and professionals in the community. Mentors from various professions participate in an informational session, mentoring event and one mentoring activity each year. In May, the mentors and the students come together to share knowledge and network. Each student has an opportunity to attend one or more activities prepared by their mentors over the course of the summer.

### Women in Science and Engineering

WCC Mentoring Women in Science and Engineering is a group being formed under the professional mentoring component of the Mentoring for Success Program.

This group gives female students studying science, mathematics or engineering concentrations opportunities to get "real world" information, encouragement, advice and access to professional networks in the field the student is aspiring to obtain a degree in.
